

## **Overland Data Raises Expectations for Fiscal First Quarter 2002**

SAN DIEGO, Oct 1, 2001 (BUSINESS WIRE) -- Overland Data Inc. (Nasdaq:OVRL) today reported that both revenue and earnings for its first fiscal quarter ended Sept. 30, 2001 are expected to exceed analyst estimates.

Revenue for the quarter should exceed \$39 million and the company expects earnings for the first quarter to be in the range of \$0.07 to \$0.09 per share. The current consensus of Wall Street estimates for the quarter consists of \$37.4 million in revenue and earnings of \$0.06 per share. Overland plans to announce complete first quarter results after the close of the market on Oct. 18, 2001.

"Although Overland's business in the eastern United States slowed as a result of the disruptions following the tragic events of September 11, 2001, elsewhere our business was strong throughout the quarter," stated Christopher Calisi, Overland's President and CEO. "We believe that many businesses will be reevaluating and strengthening their disaster recovery plans and that the market for automated tape backup solutions will see further improvement. Furthermore, we are pleased with the market acceptance of our recently released next-generation Neo(TM) series of tape libraries which is positioned at an attractive price point and offers state of the art features not enjoyed by our competition. Although cautious about these uncertain economic times, we are encouraged by our performance and remain optimistic about our future outlook given the potential for increased spending in the area of data storage and recovery."

Overland is a global supplier of storage automation solutions and related technologies designed to meet and surpass the critical requirements of high-availability network computing environments, from entry level to the enterprise. The company is a recognized leader in technology innovation and product reliability. Its award-winning products meet the critical needs of end users, distributors and OEMs in industries worldwide.
